

Last Mile Federal Funding Account




- Legislative Leadership Enacting **Senate Bill 156**
- **\$2 Billion** in multi-year **investments**
- Including **\$550 Million** planned in Fiscal Year 27-28
- Allocations per County for **Rural / Urban Parity**
- Early **Technical Assistance** for Broadband Planning
- **Engagement** with Public Entities and New Entrants
- **Investing in communities** across California and building **generational infrastructure**

Last Mile Awards Overview

106 Technical Assistance Planning Grants and 122 Infrastructure Projects Across California

- **\$1.28 billion** in grants awarded
- **58** counties with awarded grants
- **2.1+ million** Californians benefitting from investments
- **4,000** Community Anchor Institutions benefitting
- **7,500** fiber miles deploying
- **74+** projects grew from Technical Assistance grants

Investments Where Needed Most: Last Mile Broadband Affordability



- **120** Projects Offer an **Affordable Plan**
- **80** Projects in Primarily **Disadvantaged Areas**
- **54** Grants to **Public Entities** to Bolster Consumer Choice



Last Mile Projects – Spotlight on Progress



City of Gustine in Merced County

Completed project investing \$4.8 million with UnWired Broadband and benefitting 6,500 Californians.



City of Ukiah Gigabit Fiber in Mendocino County

Investing \$5.6 million with City of Ukiah and Vero Fiber and benefitting 9,100 Californians.




Terra Bella in Tulare County

Last Mile Projects – Spotlight on Progress



Chumash Fiber Network in Santa Barbara County
Total Award: **\$4.7 million**

Project Details:

- **13 Miles** of tribally-owned resilient underground fiber
- Project size **6 square miles**

Project Outcomes:

- High-speed internet connections to about **300 locations**
- Benefitting **~850 People** on their Tribal lands and surrounding parts of Santa Barbara County
- "develop it ourselves, but not alone"
