Re: **Consolidated Communications Enterprise Services, Inc. (“CCES”) Notice of Termination of State-Issued Video Franchise No. 29**

Dear Ms. Pangilinan:

Pursuant to Public Utilities Code Section 5840(j) and California Public Utilities Commission (“Commission” or “CPUC”) General Order 169, Section VII(E), Consolidated Communications Enterprise Services, Inc. (“CCES”) hereby provides notice of that it will terminate its state-issued video franchise and cease offering video service under the Digital Infrastructure and Video Competition Act of 2006 (“DIVCA”), effective June 6, 2024. CCES is the successor in interest to SureWest TeleVideo, the original franchisee who was assigned Video Franchise No. 29. This franchise was originally awarded in 2009, and following certain amendments, it was renewed as of January 1, 2019.

Contemporaneous with its March 2024 invoices, CCES is providing notice to its customers of its intention to cease providing state-franchised video service by June 6, 2024. This termination of service will not impact the availability of broadband Internet access service and will not limit any other services that CCES provides. During the 90-day period between this notice and the termination date of June 1, 2024, CCES will work with customers to assist in transitioning them to other service providers or video platforms of their choice.

This notice is being served on each of the municipalities within CCES’s video service footprint under DIVCA. Within 14 days following the service termination date, CCES will provide the required notice to the Commission and each affected municipality identifying the number of subscribers whose service was terminated and the method by which subscribers were notified of the termination. *See* Pub. Util. Code § 5840(m)(5).

This letter satisfies CCES’s obligations to provide advance notice of its intent to terminate state-franchised video service. If you have any questions, please contact me at (510) 955-1081 or at patrick@brblawgroup.com.
