VIOLATIONS

You are hereby cited with having violated sections of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from February 16, 2024, through February 22, 2024.

- (1) Operated as a charter-party carrier without valid authority in violation of Pub. Util. Code Section 5379 and CVC 14602.9 [1 count];
- (2) Advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code Section 5414.5 [2 counts].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before June 6, 2024. By way of such answer, you may either:

- (1) Pay a fine of \$4,000.00 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by June 6, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On March 11, 2024, I was assigned to investigate the operations and practices of White Rose Limousine, Inc (White Rose Limousine), after I observed their black Mercedes Sprinter (license plate: [REDACTED]) operating after expiration at the Temecula Operation on February 16, 2024.

VIOLATIONS

The investigation for February 16, 2024, through May 7, 2024, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

- **Operated as a charter-party carrier after the revocation of its operating authority in violation of Pub. Util. Code Section 5379 and CVC 14602.9 [1 count].**

On March 29, 2021, the California Public Utilities Commission's (CPUC) Transportation Licensing and Analysis Branch (TLAB) mailed White Rose Limousine a Notice of Expiration of Charter-Party Authority letter, effective March 28, 2021. This letter also advises that any operations conducted without authority to operate as a charter-party carrier of passengers are unlawful and subject to fines and penalties as set forth in the Public Utilities Code [Attachment 1].

On February 16, 2024, I led the Temecula Operation when, at approximately 3:20 PM, I observed a black Mercedes Sprinter without any TCP numbers on the vehicle at the [REDACTED] Winery (license plate: [REDACTED]). The driver dropped off five female passengers, drove to the parking lot, and parked. We approached the driver ([REDACTED], CDL: [REDACTED]). I requested a waybill, and he gave us a waybill from White Rose Limousine, Inc. TCP 20007-B. We ascertained that permit number TCP 20007-B expired on March 28, 2021, and we had the driver sign an Inspection Observation Report confirming the expired permit status. I admonished Mr. [REDACTED] and advised him that White Rose Limousine, Inc. could not operate or advertise until it had an active TCP permit. I then entered the [REDACTED] Winery and spoke to the five female

passengers/customers and Ms. [REDACTED] confirmed she paid a \$100.00 non-refundable deposit via Zelle on February 15, 2024, and she was going to pay the \$775.00 balance after the completion of their trip [Attachment 2].

- **Advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code Section 5414.5 [2 counts].**

Pub. Util. Code Section 5414.5 states: “Every corporation or person who knowingly and willfully issues, publishes, or affixes, or causes or permits the issuance, publishing, or affixing, of any oral or written advertisement, broadcast, or other holding out to the public, or any portion thereof, that the corporation or person is in operation as a charter-party carrier of passengers without having a valid certificate or permit issued under this chapter is guilty of a misdemeanor punishable, if an individual, by a fine of not more than one thousand dollars (\$1,000) or by imprisonment in the county jail for not more than six months, or by both, or, if a corporation, by a fine of not more than five thousand dollars (\$5,000).”

Business and Professions (B&P) Code Sections 17200 and 17500 state, in part, that unfair competition shall mean and include an unfair or fraudulent business act or practice and unfair, deceptive, untrue, or misleading advertising and any act prohibited by Chapter 1 of the B&P code.

On February 22, 2024, I observed White Rose Limousine advertising illegally after expiration on their website, www.[REDACTED].com, and on Facebook. These website advertisements list phone number (714) [REDACTED] [Attachment 3].

I have read the foregoing and know the contents thereof. I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief and to those matters, I believe to be true.

Authorization for transfer of the above certificate having been granted, said certificate is hereby transferred and reissued in the name of the transferee (designated herein as "Carrier") authorizing the transportation of passengers by motor vehicle over the public highways of the State of California as a CHARTER-PARTY CARRIER OF PASSENGERS, in accordance with the Public Utilities Code and subject to the following conditions:

- (1) This certificate is issued pursuant to Public Utilities Code Section 5383, and said Carrier shall operate from a radius of no more than 125 air miles from the home terminal to any point in the state. This mileage restriction applies only to vehicles seating 10 or fewer, including the driver.
- (2) No vehicle or vehicles shall be operated by said Carrier unless adequately covered by a public liability and property damage insurance policy or surety bond as required by Public Utilities Code Section 5392.
- (3) Said Carrier shall comply with all Commission orders, decisions, rules, directions, and requirements governing the operations of said Carrier including General Order Series 115 and 157 and shall remit to the Commission the Transportation Reimbursement Fee required by Public Utilities Code Section 403.
- (4) All vehicles operated under this certificated authority shall comply with the requirements of the Motor Carrier Safety Section of the California Highway Patrol. No vehicle shall be operated unless it is named in the Carrier's most recent equipment list on file with this Commission. Written amendments to the equipment list shall be filed within ten days of the date the vehicle is put into or pulled out of service.
- (5) This certificate is subject to amendment, modification, suspension or revocation as provided in the Public Utilities Code and in Commission Resolutions PE-498, PE-501, and TL-18336.
- (6) This certificate may not be sold, assigned, leased, or otherwise transferred or encumbered without Commission authorization.
- (7) This certificate does not authorize the Carrier to conduct operations on the property of or into any airport unless such operation is authorized by the airport authority involved.
- (8) This certificate does not authorize round-trip sightseeing tour service.
- (9) The use of top lights and/or taxi meters in all vehicles operated under this certificate is prohibited (D 82-05-069).
- (10) Relocation of terminal is permitted upon notification to the Commission. However, any relocation and/or addition of terminal outside the 125-air mile limit requires a new certificate and 30-day notice/publication.
- (11) **This certificate expires March 28, 2021.** It may be renewed every three (3) years upon submission and approval of a renewal application. **This renewal application should be submitted 90-days prior to the expiration date.**
