VIOLATIONS

You are hereby cited with having violated sections of the Public Utilities (Pub. Util.) Code and a California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred on December 14, 2025.

- (1) Operated as a charter-party carrier without authority in violation of Pub. Util. Code Section 5371 **[1 count]**

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before January 7, 2026. By way of such answer, you may either:

- (1) Pay a fine of \$1,500 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by January 7, 2026, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On December 15, 2025, I was assigned to investigate Atcha Rao Boppudi (hereinafter referred to as Atcha) because he was observed conducting transportation service utilizing a vehicle with license plate [REDACTED] at Levi's Stadium without CPUC authority during a joint operation with the California Highway Patrol (CHP) on December 14, 2025. As a result, his vehicle was impounded by the CHP [Attachment 1].

VIOLATIONS

The investigation for the date of December 15, 2025, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and Commission General Order (G.O.):

- **Operated as a charter-party carrier without authority in violation of Pub. Util. Code Section 5371. [1 count]**

On December 14, 2025, TEB analysis Mingfeng Li, Azita Jack and Program and Project Supervisor Shirley Lei observed Atcha leading three passengers to his vehicle (license plate [REDACTED]). After Atcha and the three passengers got into the car and were about to take off, we approached the vehicle and interviewed the driver and the three passengers. I confirmed Atcha and the passengers were not on any Transportation Network Company (TNC) platform. One of the passengers, Ricky, confirmed to Supervisor Shirley Lei that he was going to pay \$80 to Atcha to transport them from Levi's Stadium to Omni Hotel so they didn't have to wait for TNC carriers. I confirmed with the Transportation Licensing and Analysis Branch (TLAB)'s database that Atcha had never held a charter party carrier authority from the Commission. I issued an Observation Report and Cease and Desist Report to Atcha, which he acknowledged and signed [Attachment 2]. Subsequently, I submitted a Request to Impound Form (CHP [REDACTED]) to CHP Officer Kraft (Badge # [REDACTED]) to impound the vehicle [Attachment 3].

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.


