VIOLATIONS

You are hereby cited for having violated a section of the Public Utilities (Pub. Util.) Code as described below. The violation occurred on November 09, 2025.

- (1) Operated as a Charter-Party carrier without operating authority in violation of Pub. Util. Code Section 5371. [1 count]

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before December 02, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$1,500 pursuant to P.U. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by December 02, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On November 10, 2025, I was assigned to investigate Hazrat Bilal Mamozai (hereinafter referred to as Hazrat) because he was observed operating a vehicle with license plate [REDACTED] at Levi's Stadium without CPUC authority during a joint operation with the California Highway Patrol (CHP). As a result, his vehicle was impounded by the CHP on November 09, 2025 [Attachment 1].

VIOLATIONS

The investigation for the date of November 9, 2025, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and Commission General Order (G.O.):

- **Operated as a charter-party carrier without authority in violation of Pub. Util. Code Section 5371. [1 count]**

On November 09, 2025, CHP Officer [REDACTED] followed Hazrat, leading three passengers to his vehicle (license plate [REDACTED]). One of the passengers, [REDACTED], confirmed to Program and Project Supervisor Shirley Lei that he was going to pay \$60 to Hazrat to transport them from Levi's Stadium to Downtown San Jose. I confirmed with the Transportation Licensing and Analysis Branch (TLAB)'s database that Hazrat had never held a charter party carrier authority from the Commission. I issued an Observation Report to Hazrat, which he acknowledged and signed [Attachment 2]. Subsequently, I submitted a Request to Impound Form (CHP 180) to CHP Officer [REDACTED] to impound the vehicle [Attachment 3].

DECLARATION

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.
