VIOLATIONS

You are hereby cited with having violated sections of the Public Utilities (Pub. Util.) Code and a General Order (G.O.) as described below. These violations occurred during the period from July 25, 2025, to October 6, 2025.

(1) Failure to produce records, in violation of Pub. Util. Code Sections 5381 and 5389 and G.O. 157-E, Part 6.02 [1 count].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before October 30, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$ 2,000 pursuant to P.U. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission (Commission) using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by October 30, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority may be revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On July 25, 2025, I was assigned to investigate the operations and practices of EKMK INC (hereinafter referred to as EKMK) because of a referral from the California Public Utilities Commission (CPUC) Fiscal office for non-compliance with a CPUC audit notice.

VIOLATIONS


The investigation of EKMK for the period of July 25, 2025 to October 6, 2025, disclosed the following violation of the Public Utilities (Pub. Util) Code and California Public Utilities Commission (Commission) General Order (G.O.) provisions.

• Failure to produce records, in violation of Pub. Util. Code Sections 5381 and 5389 and G.O. 157-E, Part 6.02. [1 count]

On August 1, 2025, I sent EKMK a data request via email at and by certified mail (USPS # 7013 2630 0001 5484 6235) for tax returns from 2021,2022 and 2023, along with forms 1065, 1040, 1140, Schedule C, 1120S, and 1099 [Attachment 1]. The certified mail was returned to the CPUC because it was unclaimed.

On September 16, 2025, I called EKMK at and spoke with Mr. at 1:58 PM. I informed him of my data request following up to the Fiscal audit letters requesting for tax returns from 2021, 2022, and 2023. He asked me to resend the data request due to his hospitalization.

On September 17, 2025, I called ______, and spoke with Mr. _____ that there was no open case on EKMK account. I clarified that the case number was internal. I informed Mr. _____ that the data request was from the Fiscal Office of the CPUC. I sent him three audit letters and requested tax returns for 2021, 2022, and 2023. I also mentioned that I would issue a citation for non-compliance if he failed to provide the information.


