VIOLATIONS

You are hereby cited with having violated sections of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from June 1, 2024, through June 30, 2024.

- (1) Failed to enroll two (2) drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 [2 counts];
- (2) Engaged two (2) employee drivers without workers' compensation insurance in violation of Pub. Util. Code Section 5378.1 [2 counts].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before January 31, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$4,000.00 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by January 31, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On July 9, 2024, I was assigned to investigate the operations and practices of Alnagar LLC (Alnagar). This assignment came after a black 2020 Chevy Suburban SUV (License Plate: [REDACTED], VIN [REDACTED]; Driver: [REDACTED], CDL: [REDACTED]) was observed operating with TCP numbers that were not visible from 50 feet and without workers' compensation coverage. This observation occurred during the Ports America Joint Operation with the Los Angeles Department of Transportation on June 14, 2024 [Attachment 1].

VIOLATIONS

The investigation for June 14, 2023, through September 10, 2024, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

- **Failed to enroll two (2) drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 [2 counts].**

A search of the DMV EPN System on July 9, 2024, showed that the only driver enrolled under EPN requestor code [REDACTED] was Mohammed Alnagar M Elbasher, CEO, CDL: [REDACTED] [Attachment 2]. The driver observed on June 14, 2024 ([REDACTED], CDL: [REDACTED]) operated while not being enrolled under EPN requestor code [REDACTED] [Attachments 1, 2, 3 and Table 1].

On September 10, 2024, I received records from Uber Technologies, Inc. (Uber) showing three drivers and two vehicles listed under this Uber account [Attachment 3]. These Uber records also showed [REDACTED], CDL: [REDACTED], also operated multiple times in June 2024 without being enrolled under EPN requestor code [REDACTED] [Attachments 2, 3 and Table 1].

- **Engaged two employee drivers without workers' compensation insurance in violation of Pub. Util. Code Section 5378.1 [2 counts].**

Employee driver [REDACTED], CDL: [REDACTED], was observed driving on June 14, 2024, at the Ports America Joint Operation [**Attachments 1, 3 and Table 1**]. The records received from Uber show [REDACTED], CDL: [REDACTED] and [REDACTED], CDL: [REDACTED], both drove on multiple dates in June 2024 [**Attachment 3 and Table 1**]. Transportation Licensing and Analysis Branch (TLAB) records show that Alnagar LLC does not have workers' compensation insurance coverage in effect and on file with the Commission [**Attachment 4**].

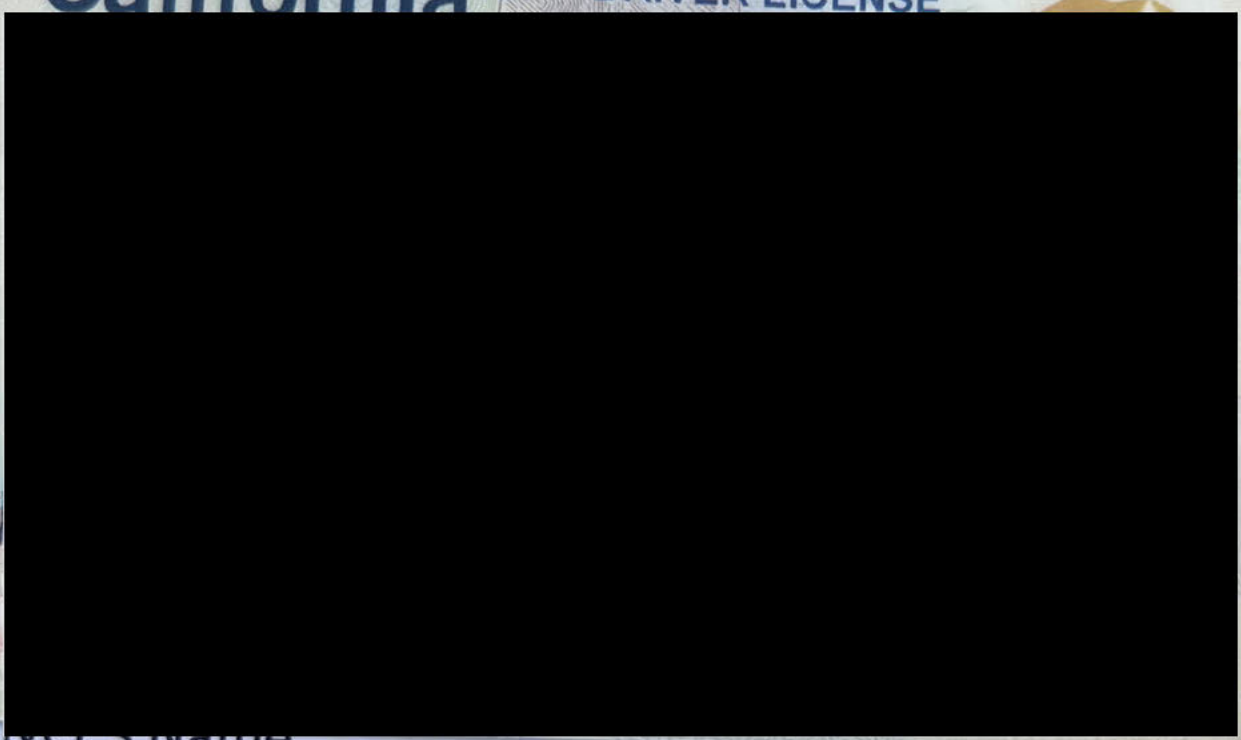

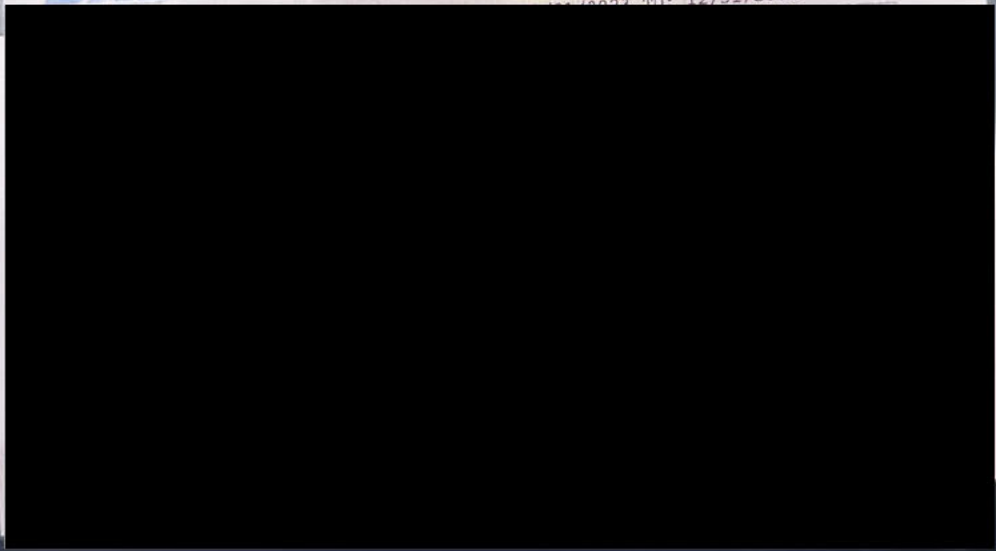


