VIOLATIONS

You are hereby cited with having violated a section of the Public Utilities Code (P.U. Code) as described below. This violation occurred during the period from November 7, 2024, through February 26, 2025.

- (1) Advertised as a charter-party carrier without valid authority, in violation of P.U. Code Section 5414.5. [2 counts]

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

The Transportation Enforcement Branch of the California Public Utilities Commission (Commission) used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before March 19, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$1,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*.) Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal*."

If you fail to respond by March 19, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On November 7, 2024, I was assigned to investigate the operations and practices of Plush Transportations LLC (Plush Transportations). During the California Public Utilities Commission's (CPUC) Transportation Enforcement Branch's (TEB) San Diego Gaslamp Joint Operation on October 26, 2024, TEB staff observed a Plush Transportations vehicle operating on a suspended charter-party carrier (TCP) authority [**Attachment 1**].

VIOLATIONS

The investigation of Plush Transportations for the period of November 7, 2024, to February 26, 2025, disclosed the following violation of the Public Utilities (PU) Code provision:

- **Advertised as a charter-party carrier without valid authority, in violation of PU Code Section 5414.5. [2 counts]**

During TEB's San Diego Gaslamp Joint Operation on October 26, 2024, TEB's Enforcement Analyst Mary Sekyi-Appiah observed a Plush Transportations vehicle, with California license plate number [REDACTED], transporting passengers [**Attachment 1**]. The CPUC record at the time showed CPUC suspended Plush Transportations' TCP authority on September 22, 2024 [**Attachment 2**]. Ms. Sekyi-Appiah served a Cease-and-Desist Notice and an Inspection Observation Report to an individual who claimed to be related to the driver of the vehicle [**Attachment 1**].

Plush Transportations' TCP authority was revoked on December 21, 2024 [**Attachment 3**] and reinstated on January 29, 2025 [**Attachment 4**]. However, on January 16, 2025, Plush Transportations was advertising on Yelp, <https://www.yelp.com/biz/plush-transportations-san-diego> [**Attachment 5**], and Instagram, [Plush Transportations LLC \(@plushtransportations\)](#) • [Instagram photos and videos](#) [**Attachment 6**] on a revoked TCP authority.

The Yelp advertisement shows the same telephone number, (619) 854-9300, that Plush Transportations has on file with the CPUC [**Attachment 7**]. Furthermore, on February 13, 2025, I called the telephone number listed on Plush Transportations' Instagram advertisement, 619-

622-3887, and reached Aleksandr (Alex) Agamirov, Managing Member of Plush Transportations
[Attachment 8].



A carrier whose certificate or permit is suspended due to failing to pass a vehicle inspection by the California Highway Patrol (CHP) (California Public Utilities Code § 5378.5, Commission Resolution TL-18336) may obtain a reinspection of its terminal and vehicles by the CHP by submitting a written request for reinstatement to CPUC and paying a reinstatement fee of one thousand dollars (\$1,000). (California Public Utilities Code § 5378.5(b)). Upon receipt of a written recommendation from CHP to suspend a carrier's operating authority, a carrier may request a hearing of the suspension by making a written request to CPUC and the CHP showing cause why the suspension should not be continued.




