VIOLATIONS

You are hereby cited as having violated sections of the Public Utilities (Pub. Util.) Code and a General Order (G.O.) as described below. These violations occurred on October 9, 2024.

- (1) Operated as a Charter-Party Carrier after revocation of authority, in violation of Pub. Util. Code Section 5379 **[1 count]**; and
- (2) Operated at an airport without an airport permit and failed to follow airport rules and regulations, in violation of Pub. Util. Code Section 5371.4(b) and G.O. 157-E, Part 3.02 **[1 count]**.

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

You are hereby called upon to answer this citation on or before April 9, 2025. By way of such an answer, you may either:

- (1) Pay a fine of \$6,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the CPUC staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See the attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by April 9, 2025, you will be in default and will have forfeited your right to appeal the Citation. The CPUC may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and CPUC orders.

INTRODUCTION

On November 4, 2024, I was assigned to investigate the operations and practices of Erhan Kantarci dba Welcome Limousine U.S. (hereinafter referred to as Mr. Kantarci) because of a San Francisco International Airport (SFO) Ground Transportation Unit (GTU) complaint alleging that Mr. Kantarci operated after revocation and without an airport permit.

HISTORY OF ENFORCEMENT

- Enforcement case records show Mr. Kantarci has a history of violating the California Public Utilities Commission's (CPUC) rules and regulations, as detailed below.

Prior Case (CSE-000094): On May 28, 2024, CPUC's Transportation Enforcement Analyst, Omar Teutle, issued Citation T.24-05-006 to Mr. Kantarci in the amount of \$4,000 for the following violations [**Attachment 1**]:

- Operated at an airport without an airport permit and failed to follow airport rules and regulations;
and
- Operated as a TCP after revocation of authority.

VIOLATIONS

I investigated Mr. Kantarci for October 9, 2024, and found violations of the following provisions of the Public Utilities (Pub. Util.) Codes and CPUC General Orders (G.O.):

- **Operated as a TCP after revocation of authority, in violation of Pub. Util. Code Section 5379. [1 count]**

Pub. Util. Code 5379 states in part that, "After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a charter-party carrier of passengers to conduct any operations as a carrier."

CPUC's Transportation and Licensing Analysis Branch (TLAB) carrier records show that Mr. Kantarci's operating authority was revoked on February 19, 2020, due to failure to maintain adequate PL&PD insurance [**Attachment 2**].

On October 9, 2024, Mr. Kantarci was issued Administrative Citation No. [REDACTED] by SFO GTU for operating after the revocation of his TCP authority [Attachment 3]. My investigation disclosed that Mr. Kantarci operated at SFO for one day after his authority was revoked.

- **Operated at an airport without an airport permit and failed to follow airport rules and regulations, in violation of Pub. Util. Code Sections 5371.4(b), 5381, and G.O. 157-E, Part 3.02. [1 count]**

G.O. 157-E, Part 3.02 states that “No carrier shall conduct any operations on the property of or into any airport unless such operations are authorized by both this Commission and the airport authority involved. Consistent failure to comply with safety or traffic rules and regulations of an airport authority may result in suspension or revocation of Commission operating authority.”

On October 9, 2024, Mr. Kantarci was issued Administrative Citation No. [REDACTED] by SFO GTU for operating at SFO without an airport permit [Attachment 3].

My investigation revealed that SFO GTU issued Mr. Kantarci an Administrative Citation for operating one day at SFO without an airport permit.

In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.
