VIOLATIONS

You are hereby cited as having violated sections of the Public Utilities (Pub. Util.) Codes and a General Order (G.O.) as described below. These violations occurred from April 8, 2024 through May 29, 2025.

1. Operated as a Charter-Party Carrier (TCP) without a valid operating authority in violation of Pub. Util. Code Section 5371 **[4 counts]**.
2. Operated at an airport without an airport permit and failure to follow airport rules and regulations in violation of Pub. Util. Code Sections 5371.4(b), 5381, and G.O. 157-E, Part 3.02 **[4 counts]**, and
3. Advertised as a charter-party carrier without a valid authority, in violation of Pub. Util. Code Section 5414.5 **[2 count]**

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

You are hereby called upon to answer this citation on or before July 1, 2025. By way of such an answer, you may either:

- (1) Pay a fine of \$5,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the CPUC staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See the attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by July 1, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The CPUC may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and CPUC orders.

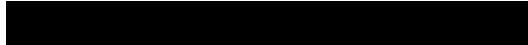

INTRODUCTION

On January 13, 2025, I was assigned to investigate the operations and practices of 24 Bay Ride LLC (hereinafter referred to as 24 Bay Ride) because of a consumer complaint alleging that 24 Bay Ride operated without California Public Utilities Commission's (CPUC) authority and an active airport permit.

HISTORY OF ENFORCEMENT

Enforcement case records show that 24 Bay Ride has a history of violating the CPUC rules and regulations, as detailed below.

On April 17, 2024, CPUC's Enforcement Analyst, Omar Teutle, served 24 Bay Ride a Cease-and-Desist (C&D) Notice for operating at San Francisco International Airport (SFO) on April 8, 2024, without CPUC authority [**Attachment 1**]. On June 27, 2024, CPUC's Enforcement Analyst, Omar Teutle, served 24 Bay Ride another C&D Notice, for operating at SFO on June 12, 2024, without CPUC authority [**Attachment 2**].

VIOLATIONS

I investigated 24 Bay Ride from April 8, 2024 through May 29, 2025, and found violations of the following provisions of the Public Utilities (Pub. Util.) Codes and a CPUC's General Order (G.O.):

- **Operated as a Charter-Party Carrier (TCP) without a valid operating authority in violation of Pub. Util. Code Section 5371. [4 counts]**

Pub. Util. Code 5371 states that "No charter-party carrier of passengers excepting transit districts, transit authorities or cities owning and operating local transit systems themselves or through wholly owned nonprofit corporations shall engage in transportation services made subject to this chapter without first having obtained from the commission a certificate that public convenience and necessity require the operation, except that certain specific transportation services as defined in Section 5384 may be conducted under authority of a permit issued by the commission."

CPUC's Transportation and Licensing Analysis Branch (TLAB) records show that 24 Bay Ride has never held a TCP operating authority.

On April 8, 2024, the SFO Ground Transportation Unit (GTU) issued Citation # [REDACTED] to 24 Bay Ride for operating at SFO without CPUC authority and an airport permit [**Attachment 3**]. On June 12, 2024, the San Francisco Police Department (SFPD) issued Citation # [REDACTED] to 24 Bay Ride for the same violations [**Attachment 4**]. On January 7, 2025, the SFPD issued Citation # [REDACTED] to 24 Bay Ride [**Attachment 5**], and SFO GTU issued a C&D Notice [**Attachment 6**] for operating at SFO without the required CPUC authority and an airport permit. Additionally, on March 24, 2025, SFO GTU issued Citation # [REDACTED] to 24 Bay Ride [**Attachment 7**], and SFO GTU issued a C&D Notice

[Attachment 8] on March 30, 2025, for operating at SFO without the required CPUC authority and an airport permit. My investigation disclosed that 24 Bay Ride conducted four days of operations without CPUC authority [Table 1 and Attachments 3, 4, 5, 6, 7, and 8].

- **Operated at an airport without an airport permit and failure to follow airport rules and regulations in violation of Pub. Util. Code Sections 5371.4(b), 5381, and G.O. 157-E, Part 3.02. [4 counts]**

G.O. 157-E, Part 3.02 states that “No carrier shall conduct any operations on the property of or into any airport unless such operations are authorized by both this Commission and the airport authority involved. Consistent failure to comply with safety or traffic rules and regulations of an airport authority may result in suspension or revocation of Commission operating authority.”

On April 8, 2024, the SFO GTU issued Citation # ██████ to 24 Bay Ride for operating at SFO without CPUC authority and an airport permit. On June 12, 2024, the SFPD issued Citation # ██████ to 24 Bay Ride for operating at SFO for similar violations. On January 7, 2025, SFPD issued Citation # ██████ to 24 Bay Ride, while the SFO GTU issued a C&D Notice on January 8, 2025, for operating at SFO without CPUC authority and an airport permit. Additionally, on March 24, 2025, SFO GTU issued Citation # ██████ and another C&D Notice on March 30, 2025, to 24 Bay Ride for operating at SFO without the required CPUC authority and an airport permit. My investigation disclosed that 24 Bay Ride operated for four days at SFO without an airport permit [see Table 1 and Attachments 3, 4, 5, 6, 7, and 8].

- **Advertised as a charter-party carrier without a valid authority, in violation of Pub. Util. Code Section 5414.5 [2 count]**

On May 29, 2025, I found that 24 Bay Ride is advertising passenger transportation services without authority on its website, <https://www.24bayride.com/> [Attachment 9] and Instagram, https://www.instagram.com/24bayride?utm_source=ig_web_button_share_sheet&igsh=ZDNlZDc0MzIxNw== [Attachment 10]. My investigation disclosed that 24 Bay Ride continues to advertise without authority, despite two C&D Notices being served.

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.

The California Public Utilities Commission (CPUC) became aware that you are operating without a valid authority.

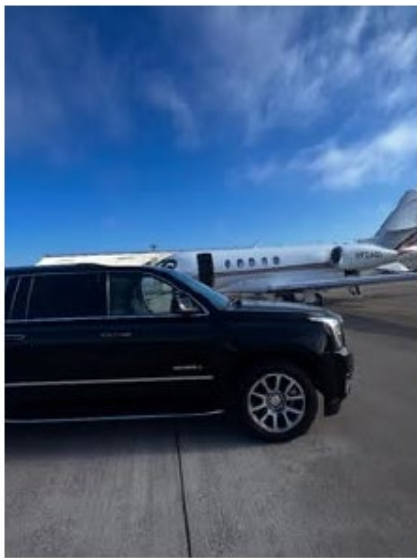
