### VIOLATIONS

You are hereby cited as having violated a section of the Public Utilities (Pub. Util.) Code and California Vehicle Code (CVC) as described below. The violation occurred during the period of June 18, 2025.

(1) Operated as a Charter-Party Carrier after revocation of authority, in violation of Pub. Util. Code Section 5379 and CVC 14602.9. **[1 count]** 

### **STATEMENT OF FACTS**

The above violation is documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

#### **RESPONSE**

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before July 10, 2025. By way of such an answer, you may either:

- Pay a fine of \$1,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the CPUC staff will deem the matter closed, or
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See the attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by July 10, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The CPUC may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and CPUC orders.

#### INTRODUCTION

On June 19, 2025, I was assigned to investigate the operations and practices of Duilio Magalhaes Dba Luxstar Limousines (hereinafter referred to as Duilio Magalhaes), charter-party carrier (TCP) 20806-P, after Duilio Magalhaes was observed operating after revocation of its TCP authority during our joint safety operation at the San Francisco International Airport (SFO) on June 18, 2025. Duilio Magalhaes's Chevrolet Suburban SUV (License Plate

) was subsequently impounded by California Highway Patrol (CHP) for operating after revocation of its TCP authority [Attachment 1].

#### VIOLATIONS

I investigated Duilio Magalhaes for the period of June 18, 2025, to June 20, 2025, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and California Vehicle Codes (CVC).

### • Operated as a Charter-Party Carrier (TCP) after revocation of authority, in violation of Pub. Util. Code Section 5379 and CVC 14602.9. [1 count].

Pub. Util. Code 5379 states in part that "After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a charter-party carrier of passengers to conduct any operations as a carrier."

CVC 14602.9 states in part that "A peace officer may impound a bus or limousine of a charter-party carrier for 30 days if the officer determines that any of the following violations occurred while the driver was operating the bus or limousine of the charter-party carrier: the driver was operating the bus or limousine of a charter-party carrier when the charter-party carrier did not have a permit or certificate issued by the Public Utilities Commission, pursuant to Section 5375 of the Public Utilities Code."

A review of the CPUC's Transportation Licensing and Analysis Branch records shows that Duilio Magalhaes entered revocation of its TCP authority on March 3, 2022 [Attachment 2].

During the SFO joint safety operation, a vehicle bearing California license plate number was observed parked in the SFO International Arrivals Terminal with two passengers inside, soliciting TCP business [Attachment 3]. During my safety compliance check on Duilio Magalhaes an email verification of passengers was provided,

, arriving on **[Attachment 4]**. I issued Duilio Magalhaes a Notice to Cease-and-Desist and an Observation Report [**Attachment 5**]. I submitted the Request to Impound form to CHP **[10]**, who impounded the vehicle on June 18, 2025 [see Attachment 1].



#### **Order of Revocation**

This is notice from the California Public Utilities Commission (CPUC) that the operating authority listed on this letter is revoked effective March 03, 2022.

#### Failure to maintain PLPD insurance

After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a Passenger Stage Corporation (PSC) or a Transportation Charter-Party carrier (TCP) of passengers to conduct any operations as a carrier. (California Public Utilities Code §§ 1045, 5379). Unlawful operations are subject to fines and penalties as set forth in the California Public Utilities Code and may include permanent revocation of your operating authority or being permanently barred from receiving an operating authority.

There is a ninety (90) day period in which a revoked carrier may apply to reinstate the revoked operating authority unless it was permanently revoked.






