VIOLATIONS

You are hereby cited for having violated sections of the Public Utilities Code (Pub. Util. Code) and a California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from January 1, 2026, through April 15, 2026.

- (1) Failed to maintain and enroll drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice Program (EPN) in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E, Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 [**2 counts**];
- (2) Failed to enroll drivers in a mandatory Controlled Substance and Alcohol Testing (CSAT) Certification Program for Pre-Employment Testing in violation of Pub. Util. Code Section 5374(a)(1)(I) and G.O. 157-E, Part 10 [**2 counts**];
- (3) Failed to maintain a current equipment list with the Commission in violation of Pub. Util. Code Sections 5381 and 5411 and G.O. 157-E, Part 4.01 [**1 count**]; and
- (4) Advertised as a charter-party carrier during suspension of operating authority in violation of Pub. Util. Code Section 5414.5 [**3 counts**].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before June 11, 2026. By way of such answer, you may either:

- (1) Pay a fine of \$7,000, pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document: "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by June 11, 2026, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

## INTRODUCTION

On March 10, 2026, I was assigned to investigate the operations and practices of See Hollywood Tour, Inc., dba Hollywood city tours (hereinafter referred to as See Hollywood). On February 27, 2026, the Transportation Enforcement Branch (TEB) observed See Hollywood's employee-driver, Sam Moshfegh, transporting passengers in its 2010 Ford Econoline Bus (with license plate number [REDACTED]). This vehicle had not yet been stated on See Hollywood's equipment list [Attachment 1].

## HISTORY OF ENFORCEMENT

**CSE-000226.** On August 15, 2024, Enforcement Analyst Steve Esguerra served See Hollywood with Citation T.24-08-006 for operating and advertising after revocation of authority. On or about August 19, 2024, See Hollywood paid the \$5,000 fine [Attachment 2].

**CSE-000202.** On September 23, 2024, Enforcement Analyst LaTasha James served See Hollywood with a Warning Letter for operating during suspension of authority and advertising larger vehicles outside of authority. On October 3, 2024, See Hollywood executed the Warning Letter [Attachment 3].

**CSE-000337.** On January 29, 2025, Enforcement Analyst Shawndra Miles served See Hollywood with a Notice to Cease and Desist for advertising after expiration of authority [Attachment 4].

## VIOLATIONS

I investigated See Hollywood from January 1, 2026, to April 15, 2026, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.):

- **Failed to maintain and enroll drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice Program (EPN) in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E, Part 5.02, and the California Vehicle Code (CVC) Section 1808.1. [2 counts]**

On March 27, 2026, I received waybills from See Hollywood showing that employee-driver Jorge Blanco operated for See Hollywood on January 2, 2026, January 3, 2026, and January 10, 2026. On March 30, 2026, I received another waybill reflecting the TEB's observation that another employee-driver Sam Moshfegh operated for See Hollywood on February 27, 2026 [Attachment 5, Table 1].<sup>1</sup> On March 19, 2026, I conducted a search using See Hollywood's requestor code, [REDACTED], in the DMV EPN Program. That search showed that both Jorge Blanco and Sam Moshefegh had not been enrolled in See Hollywood's DMV EPN Program until March 18, 2026 [Attachment 6].

- **Failed to enroll drivers in a mandatory Controlled Substance and Alcohol Testing (CSAT) Certification Program for Pre-Employment Testing in violation of Pub. Util. Code Section 5374(a)(1)(I) and G.O. 157-E, Part 10. [2 counts]**

On March 12, 2025, I emailed CSAT Program Consultant Danny Yagubyan at [REDACTED] a data request for a list of driver-enrollees in See Hollywood's contract with New Era Drug Testing. That same day, I received the list. Employee-drivers Jorge Blanco and Sam Moshfegh had not yet been enrolled in See Hollywood's CSAT Program [Table 1, Attachment 7].

- **Failed to maintain a current equipment list with the Commission in violation of Pub. Util. Code Sections 5381 and 5411 and G.O. 157-E, Part 4.01. [1 count]**

See Hollywood's waybills show that it has been operating the 2010 Ford Econoline (license plate number [REDACTED]) since February 27, 2026. However, Transportation Licensing and Analysis Branch (TLAB) records show that this vehicle had not yet been listed under See Hollywood's equipment list [Attachment 8].

- **Advertised as a charter-party carrier during suspension of operating authority in violation of Pub. Util. Code Section 5414.5. [3 counts]**

<sup>1</sup> In See Hollywood's March 27, 2026, response to my data request, Movses Marjanian withheld the waybill for the date of TEB's observation. Once I emailed Movses Marjanian that the TEB observed another driver using unlisted equipment on February 27, 2026, Movses Marjanian emailed See Hollywood's responsive waybill to me.

On March 15, 2026, TLAB sent an Order of Suspension to See Hollywood [Attachment 9]. However, See Hollywood continued advertising as a charter-party carrier on its website (<http://www.seehollywoodtour.com/>) on March 16, 2026; March 18, 2026; and March 19, 2026, until its authority was restored on March 20, 2026 [Attachment 10].

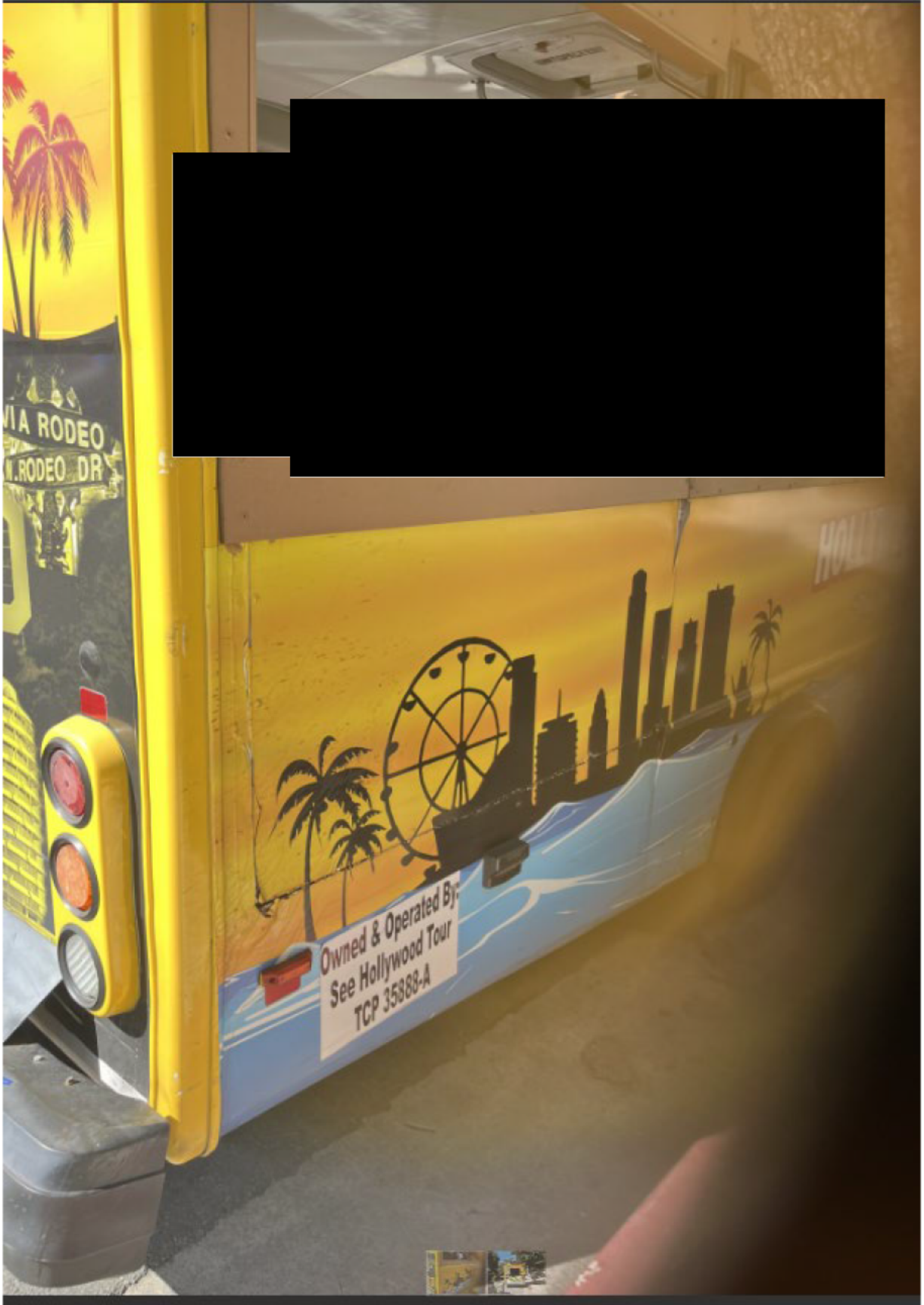

**NOTICE TO CEASE AND DESIST**

Dear Mr. Marjanian,

On December 18, 2024, your Charter-Party Carrier (TCP) authority expired. On January 27, 2024, the California Public Utilities Commission's (CPUC) Transportation Enforcement Branch (TEB) became aware See Hollywood Tour, Inc. is advertising without valid authority.

Pub. Util. Code Section 5379 states in part that it is unlawful for a TCP to conduct any operations after cancellation or revocation, or during the period of its suspension, or after the expiration of its authority. Pub. Util. Code Section 5414.5 states that it is unlawful to publish or advertise without valid authority. Advertisements include, but are not limited to, advertising in local directories or Yellow Pages, business cards, and websites.

Pub. Util. Code Section 5387 states in part that a charter-party carrier shall have its authority to operate as a TCP permanently revoked by the California Public Utilities Commission (CPUC) if it operates a bus without having been issued a valid authority from the CPUC.

**See Hollywood Tour, Inc. must immediately cease and desist from any and all unlawful operations, including advertising. Pub. Util. Code Section 5411 states in part that any carrier which operates without a valid authority is guilty of a misdemeanor and is punishable by a fine of not less than \$1,000.**

This letter places your company on notice that continued violations of the law without the required authority may result in enforcement actions, including criminal prosecutions. There will be no further warnings.

Dear See Hollywood Tour, Inc.:

The California Public Utilities Commission's (Commission) Consumer Protection and Enforcement Division (CPED) Transportation Enforcement Branch (TEB) is currently reviewing the Commission's records for intrastate transportation carriers that are regulated by the Commission.

Public Utilities Code Section 5389 authorizes the Commission and its staff to have access at any time to the land, buildings, or equipment of a charter-party carrier of passengers used in connection with the operation of its business and may inspect the accounts, books, papers, and documents of the carrier.

General Order 157-E, Part 6.01 specifically states in part that every carrier shall institute and maintain in its offices a set of records which reflect information as to the transportation services performed, including waybills, driver records, and safety and maintenance records including copies of all lease and sub-carrier agreements. Such records shall be maintained for a minimum period of three years.

Pursuant to Public Utilities Code Section 5389, the TEB is requesting a review of the Charter-Party intrastate transportation records for See Hollywood Tour, Inc. Failure to provide access to records is a misdemeanor punishable by a maximum of \$5,000, where each violation is a separate and distinct offense (Public Utilities Code Section 2110).

We request that you present your documents listed below in electronic form. Please scan the following documents and email a copy to Evan Schwartz at [Evan.Schwartz@cpuc.ca.gov](mailto:Evan.Schwartz@cpuc.ca.gov) by March 19, 2026.

1. Your current public liability and property damage insurance policy showing the schedule of vehicles and drivers insured, including the dates on which they became insured,
2. The current service agreement with your drug consortium and a list of all drivers contractually enrolled in it, also showing the dates added and/or deleted from it, and
3. Waybills for all intrastate TCP transportation, including transportation performed as See Hollywood Tour, Inc., from January 1, 2026, to March 1, 2026, showing vehicles, including license plate numbers, operated by See Hollywood Tour, Inc., for business use and the drivers, including their driver's license numbers, who operated these vehicles used for business by See Hollywood Tour, Inc.

TEB reserves the right to amend, add to or revise this Data Request in the future if necessary.

Any responsive records provided by you that have been properly labeled and submitted as confidential will be treated as such under Public Utilities Code Section 583 (see also General Order 66-D). Confidential documents will not be released to the public except as required by law following a Public Records Request and redaction of confidential material.

After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a Passenger Stage Corporation (PSC) or a Transportation Charter-Party carrier (TCP) of passengers to conduct any operations as a carrier. (California Public Utilities Code §§ 1045, 5379). Unlawful operations are subject to fines and penalties as set forth in the California Public Utilities Code and may include permanent revocation of your operating authority or being permanently barred from receiving an operating authority.

A carrier whose certificate or permit is suspended due to failing to pass a vehicle inspection by the California Highway Patrol (CHP) (California Public Utilities Code § 5378.5, Commission Resolution TL-18338) may obtain a reinspection of its terminal and vehicles by the CHP by submitting a written request for reinstatement to CPUC and paying a reinstatement fee of one thousand dollars (\$1,000).
