INTRODUCTION

On August 28, 2025, I was assigned to investigate the operations and practices of Lush Limo Coach, LLC (hereinafter referred to as Lush Limo). This assignment came after the Transportation Enforcement Branch (TEB) received a complaint on August 21, 2025 alleging Lush Limo continued to operate and advertise during suspension of its authority. The complainant alleges two drivers are driving for Lush Limo ([REDACTED] [REDACTED], CDL: [REDACTED] and “neighbor” [REDACTED] Oceanside, CA 92054).

HISTORY OF ENFORCEMENT

On October 26, 2024, the San Diego Police Department (SDPD) impounded Lush Limo’s black 2016 Mercedes Sprinter (license plate [REDACTED], VIN [REDACTED]) from driver [REDACTED], CDL: [REDACTED] for operating during revocation of its authority at a joint operation in the San Diego Gaslamp District (Case: CSE-283).

On October 29, 2024, TEB staff served Lush Limo with a \$3,000 citation (T.24-10-008) for operating and advertising during revocation. Lush Limo subsequently paid the \$3,000 fine [Attachment 1].

VIOLATION

The investigation for August 28, 2025-December 1, 2025, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

- **Advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code Sections 5411 and 5414.5 [1 count].**

On August 13, 2025, Lush Limo’s TCP permit (TCP 38806-B) was suspended for failure to maintain Public Liability & Property Damage insurance [Attachment 3].

On August 25, 2025, I found Lush Limo advertising illegally on their website: [REDACTED].com, Facebook, Instagram and Yelp accounts [Attachment 2].

On November 11, 2025, Lush Limo’s TCP permit (TCP 38806-B) was revoked for failure to maintain Public Liability & Property Damage insurance [Attachment 3].

On December 1, 2025, I emailed a Notice to Cease and Desist, Order of Suspension (8/13/2025) and an Order of Revocation (11/11/2025) to Lush Limo. I also spoke to Amber Dawn Gibson, Owner advising she cannot operate or advertise until she has an active/valid TCP permit [**Attachment 3**].

I have read the foregoing and know the contents thereof. I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.

NOTICE TO CEASE AND DESIST

Dear Ms. Amber Dawn Gibson:

On August 13, 2025, your Charter-Party Carrier (TCP) authority was suspended and subsequently revoked on November 11, 2025 for failure to maintain Public Liability and Property Damage insurance.

Public Utilities (Pub. Util.) Code Section 1045 states in part that after cancellation or revocation, or during the period of its suspension, it is unlawful for a PSC to conduct any operations as a carrier. Pub. Util. Code Section 1034.5 states that it is unlawful to publish or advertise without holding a valid authority. Advertisements include, but are not limited to, advertising in local directories or Yellow Pages, business cards, websites, etc.

Pub. Util. Code Section 5379 states in part that it is unlawful for a TCP to conduct any operations after cancellation or revocation, or during the period of its suspension, or after the expiration of its authority. Pub. Util. Code Section 5414.5 states that it is unlawful to publish or advertise without a valid authority. Advertisements include, but are not limited to, advertising in local directories or Yellow Pages, business cards, websites, etc.

Lush Limo Coach, LLC must immediately cease and desist from any and all unlawful operations, including advertising. Pub. Util. Code Section 5411 states in part that any carrier which operates without a valid authority is guilty of a misdemeanor and is punishable by a fine of not less than \$1,000.

This letter places your company on notice that continued violations of the law without the required authority may result in enforcement actions, including criminal prosecutions. There will be no further warnings.

(California Public Utilities Code § 5378.5(b)). Upon receipt of a written recommendation from CHP to suspend a carrier's operating authority, a carrier may request a hearing of the suspension by making a written request to CPUC and the CHP showing cause why the suspension should not be continued.
