#### **VIOLATIONS**

You are hereby cited as having violated a section of the Public Utilities (Pub. Util.) Code as described below. The violation occurred during the period of March 25, 2026.

- (1) Engaged one employee-driver without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the California Public Utilities Commission (CPUC), in violation of Pub. Util. Code Section 5378.1. **[1 count]**

## STATEMENT OF FACTS

The above violation is documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

## RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before May 26, 2026. By way of such an answer, you may either:

- (1) Pay a fine of \$2,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to CPUC using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by May 26, 2026, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

## INTRODUCTION

On April 3, 2026, I was assigned to investigate the operations and practices of Galustyan Transportation LLC (hereinafter referred to as Galustyan) due to a complaint alleging that Galustyan operated at San Francisco International Airport (SFO) without Worker's Compensation (WKCP) insurance on file with the California Public Utilities Commission (CPUC).

## VIOLATIONS

I investigated Galustyan for the period of March 25, 2026, and found a violation of the following provision of the Public Utilities (Pub. Util.) Code:

- **Engaged one employee-driver without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the CPUC, in violation of Pub. Util. Code Section 5378.1. [1 count]**

On March 25, 2026, driver [REDACTED] was observed operating on behalf of Galustyan at SFO while unlisted as a driver in the Transportation Licensing and Analysis Branch (TLAB) database. CPUC's Enforcement Analyst, Darwin Agar, captured photo evidence and issued Galustyan an Observation Report for operating without WKCP insurance [Attachment 1]. Driver [REDACTED] is not listed as a member on Galustyan's Statement of Information [Attachment 2]. In addition, records from the CPUC's TLAB indicate that Galustyan has no employees on file and does not maintain an active WKCP insurance policy on file and in effect with the CPUC [Attachment 3]. My investigation disclosed that Galustyan operated for one day without evidence of WKCP insurance.

## DECLARATION

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.



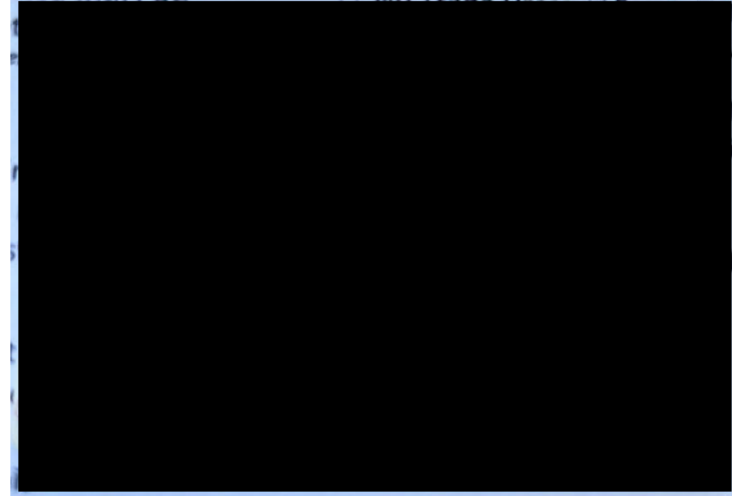
