VIOLATIONS

You are hereby cited as having violated a section of the Public Utilities (Pub. Util.) Code as described below. The violation occurred on November 10, 2025.

(1) Operated as a Charter-Party Carrier (TCP) after expiration of authority, in violation of Pub. Util. Code Section 5379. [1 count]

STATEMENT OF FACTS

The above violation is documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before March 5, 2026. By way of such an answer, you may either:

- (1) Pay a fine of \$1,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to CPUC using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by March 5, 2026, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

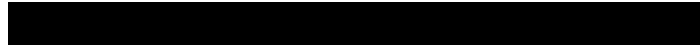

INTRODUCTION

On December 1, 2025, I was assigned to investigate the operations and practices of Mandalay Limousine Transportation (hereinafter referred to as Mandalay) because of a complaint alleging that Mandalay operated at Oakland International Airport (OAK) after expiration of its Charter-Party Carrier (TCP) authority.

VIOLATIONS

I investigated Mandalay for the period of November 10, 2025, and found a violation of the following provisions of the Public Utilities (Pub. Util.) Code and California Public Utilities Commission (CPUC) General Order (G.O.):

- **Operated as a Charter-Party Carrier (TCP) after expiration of authority, in violation of Pub. Util. Code Section 5379. [1 count]**

On July 4, 2025, CPUC's Transportation and Licensing Analysis Branch (TLAB) sent a Notice of Expiration of Operating Authority to Mandalay via U.S. Mail [**Attachment 1**]. The Notice stated that Mandalay's operating authority expired on July 4, 2025, and any unlawful operations are subject to fines and penalties as outlined in the Pub. Util. Code 5411.

On November 10, 2025, Oakland International Airport (OAK), Landside Operation, Airport Operation Specialist II [REDACTED] Gonzalez issued Mandalay Citation #1751767953 [**Attachment 2**] for operating after expiration of authority. My investigation disclosed that Mandalay operated one day and conducted one trip after expiration of its TCP authority.

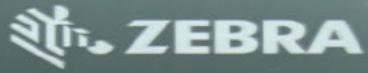
