TO: Parties Interested in the CPUC's Tribal Land Transfer Policy

Enclosed is Draft Resolution E-5076 of the Energy Division. The Draft Resolution is in response to the Commission's own motion. It will appear on the agenda at the next Commission meeting, which is at least 30 days after the date of this letter. The Commission may vote on this Resolution at that time or it may postpone a vote until a later meeting. When the Commission votes on a Draft Resolution, it may adopt all or part of it as written, amend, modify or set it aside and prepare a different Resolution. Only when the Commission acts does the Resolution become binding on the parties.

The CPUC has provided notice of this Draft Resolution as widely as possible to potential interested entities. Several lists were used to widely notice the Draft Resolution, including all electric and gas investor owned utilities, each energy utility's General Order 96-B Service List and several other lists.

The comment period for this Draft Resolution has been extended. Parties who submitted comments may resubmit or amend their comments on the Draft Resolution. All comments on the Draft Resolution must be received by Energy Division by September 22, 2020. All reply comments on the Draft Resolution must be received by Energy Division by October 6, 2020. Comments shall be limited to fifteen pages in length and should list the recommended changes to the Draft Resolution.
