Purpose: In 2019, the California Public Utilities Commission (CPUC) adopted the [Environmental and Social Justice \(ESJ\) Action Plan](#) to serve as a commitment to furthering principles of environmental and social justice, as well as an operating framework with which to integrate ESJ considerations throughout the agency’s work. One of the critical topics addressed in the ESJ Action Plan is Workforce Development and High Road Transition. This goal aims to deliver on principles of economic equity and focus workforce-related provisions on job quality and access.

In 2020, Governor Gavin Newsom issued [Executive Order N-79-20](#) to accelerate climate change mitigation efforts and build a more sustainable and inclusive economy. Following the Executive Order, the CPUC and the California Workforce Development Board (CWDB) signed the first-ever [Memorandum of Understanding](#) to collaboratively ensure that investments in clean energy and transportation sustainability result in high-quality jobs and greater access to career opportunities for disadvantaged Californians.

As California transitions to a clean energy future, the High Road Workforce En Banc will facilitate discussions between the CPUC, CWDB, California Labor & Workforce Development Agency, California Energy Commission, Office of Energy Infrastructure Safety, local community-based organizations, representatives from labor unions and academia, Tribal representatives and the regulated investor-owned utilities to gain a better understanding of the status of current workforce initiatives, challenges, and opportunities in key policy areas for energy efficiency, renewable energy, building decarbonization, vegetation management, and transportation electrification as well as water.
