Issue Summary SED reviewed the Damage Prevention Program Procedure 3.01 in Central Valley Gas Storage's (CVS) Operation and Maintenance Manual and found that the procedure is still referencing some parts of the California Government Code 4216 that has changed. For example, the 4216.2(f) and 4216.2(e) requirements on page 233 of 656 of the Operation and Maintenance Manual are no longer the current requirements stated in 4216.2(f) and

4216.2(e). CVS should review the current California Marking Guidelines in its Operation and Maintenance Manual and make any necessary updates to reflect the current requirements.

In addition, there were some important changes in the past 6 years with California Government Code 4216 that might be applicable to CVS's operations. For example, 4216.3(c)(1)(a) states that, "On and after January 1, 2021, every operator shall supply an electronic positive response through the regional notification center before the legal excavation start date and time." 4216.3 (a) (5) states that, "Commencing January 1, 2023, all new subsurface installations shall be mapped using a geographic information system and maintained as permanent records of the operator." SED recommends that CVS review the current California Government Code 4216 requirements and make the necessary updates to CVS's procedures.

CVGS has updated several sections of its procedures in response. The revisions are attached.

The affected sections are as follows:

CVGS O&M Section 3.01 was updated to reflect the latest changes to CGC 4216 and the California Marking Guidelines.

CVGS O&M Section 3.01-5.4.2 was updated to comply with 4216.2 (e).

CVGS O&M Section 3.01-5.4.2 was also updated to comply with 4216.3 (c) (1) (A).

CVGS O&M Section 3.01 -5.6.22 was updated to comply with 4216.3 (C) (5).

CVGS O&M Section 3.01-8.7.1 was updated to comply with 4216.2 (f)
