This Draft Resolution SPD-37 of the Safety Policy Division is issued in response to the requirements of Senate Bill (SB) 884 that directs regulated large electrical corporations to each submit a 10-year distribution infrastructure undergrounding plan, and conditional approval of related costs.

This Draft Resolution will appear on the agenda at the next Commission meeting to be held September 18, 2025. When the Commission votes on a Draft Resolution it may adopt all or part of it as written, or amend, modify, or set it aside and prepare a different Resolution. The Resolution becomes binding on the parties only upon action by the Commission.

Any member of the public may serve comments on the Draft Resolution as provided in Public Utilities Code § 311(g) and Rule 14.5 of the Commission's Rules of Practice and Procedure (Rules).

Comments must be served on the entire service list to which the Draft Resolution was served on the same date that the comments are submitted to the Safety Policy Division. Comments shall not exceed 20 pages in length. Comments will not be accepted on Appendix 2 of Attachment A to this Draft Resolution, SB 884 Project List Data Requirements Guidelines.

Comments shall include a subject index listing the recommended changes to the Draft Resolution, a table of authorities, and an appendix setting forth proposed findings of fact. Comments shall focus on factual, legal or technical errors in the Draft Resolution and in citing such errors shall make specific references to the record or applicable law. Comments which fail to do so will be accorded no weight. Comments proposing specific changes to the Draft Resolution shall include supporting findings of fact.

Reply comments may be filed and are due by September 9, 2025, at 5:00 PM. Replies shall be submitted and served in the same manner as opening comments and shall not exceed 5 pages in length. Replies shall be limited to identifying misrepresentations of law, fact, or condition of the record contained in the comments of other parties.
