## Purpose:

Pursuant to Senate Bill (SB) 884 (McGuire; Stats. 2022, Ch. 819), the California Public Utilities Commission's (CPUC or Commission) data requirements for a large electrical corporation's Electrical Undergrounding Plan (EUP) intended to mitigate wildfire risk in the High Fire Threat District (HFTD), will be complex and require coordination with the Office of Energy Infrastructure Safety's (Energy Safety) Guidelines and data templates. The purpose of the SB 884 Project List Data Templates Technical Working Groups (TWG) is for Safety Policy Division (SPD) to present on and for stakeholders to discuss data templates, which would be required to be filed with a EUP Phase 2 Application to the Commission. The TWGs will allow for open discussion regarding what should be the information requirements and format of the templates. In preparation for the TWGs, SPD developed an Excel-based data template as well as a PDF-based template guideline document. The guideline document includes the field name, field description, and field value constraints for each variable in the stakeholder's draft data template. During the TWGs, stakeholders will discuss why the utility should include this data in its EUP Phase 2 Applications.

## Expected Outcome:

Workshop attendees will provide feedback on SPD's data template as well as discuss the benefits and costs of various information and formatting requirements that the Commission should consider in the SB 884 Project List Data Requirements Guideline.
