Summary: SCE reports the following event as it may meet the significant public attention reporting requirement. On August 19, 2022, a wildfire was reported in Azusa in the area of North San Gabriel Canyon and Old San Gabriel Canyon Road. Preliminary information indicates that the reported alarm time of the fire was 3:16 p.m. SCE records indicate that the Jarvis 12kV distribution circuit experienced a circuit interruption near in time to the reported alarm time of the fire. Based on our preliminary investigation, the cause of the circuit interruption is believed to be Mylar balloons. The suppressed fire was reported to be approximately 9.6 acres. There was no reported property damage or injuries resulting from the fire. Our investigation is ongoing
