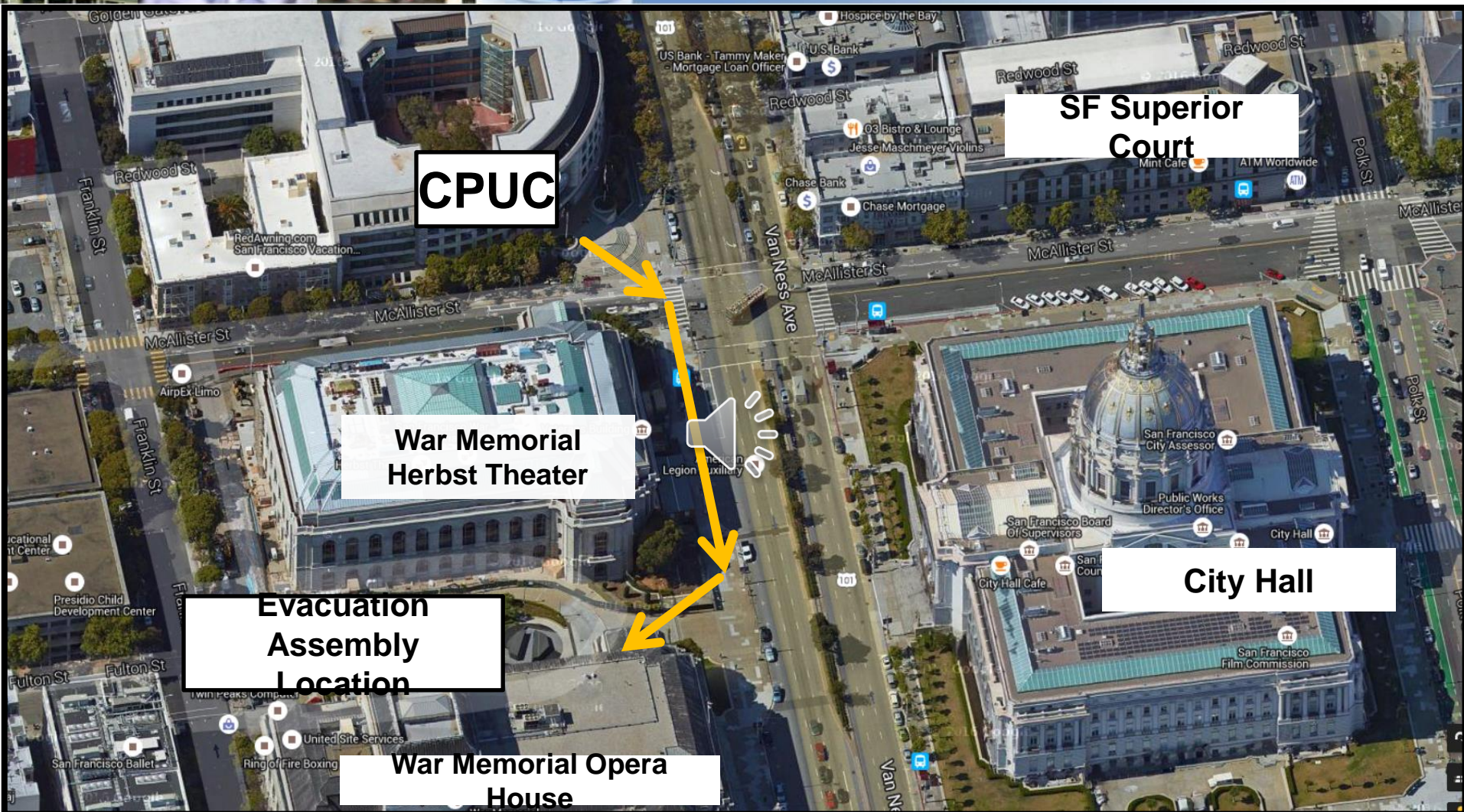
Emergency Evacuation

Item #24 [17555] – Modifications to the Energy Efficiency Three-Prong Test Related to Fuel Substitution

R.13-11-005

Order Instituting Rulemaking Concerning Energy Efficiency Rolling Portfolios, Policies, Programs, Evaluation, and Related Issues.

Ratesetting

Comr Randolph - Judge Fitch

PROPOSED OUTCOME:

- Modifies the three-prong test in the context of energy efficiency and renames it the Fuel Substitution Test.
- The Fuel Substitution Test shall be applied at the individual measure level, and shall continue to require that measures save energy and improve the environment by reducing greenhouse gas emissions.
- Individual measures shall not be subject to a cost-effectiveness screen, but instead all costs and benefits of fuel substitution measures shall be included in the energy efficiency portfolio-level cost-effectiveness calculations of any program administrator sponsoring a fuel substitution measure, with certain assumptions as further specified in this decision.
- Costs and benefits of fuel substitution shall accrue to the ratepayers of the new fuel, with a corresponding energy savings credit to the original-fuel utility.
