Order Instituting Rulemaking to Establish Energization Timelines.

Quasi-Legislative

PROPOSED OUTCOME:

- Adopts new energization targets for Pacific Gas and Electric Company, San Diego Gas & Electric Company, and Southern California Edison Company.
- Establishes new energization timeline reporting requirements.
- Creates a customer complaint mechanism to improve the Commission's insight into energization delays.

SAFETY CONSIDERATIONS:

• There are no safety considerations associated with this decision.

ESTIMATED COST:

• \$5 million over five years (\$1 million per year) to improve the Commission's Energy Division's ability to analyse, collect, track and report utility data to the public.

PROPOSED OUTCOME:

- Sets a 9.77 cost of equity for all companies.
- Approves the actual cost of debt for Calaveras Telephone Company (2.84%), Foresthill Telephone Company (2.74%), Kerman Telephone Co. (3.00%), The Ponderosa Telephone Co. (2.9%), Sierra Telephone Company Inc. (3.83%) and Volcano Telephone Company (5.22%).
- Adopts an average cost of debt based on the average of the lowest and highest of the above six companies (3.98%) for the four companies with no debt at the time of the application – Cal-Ore Telephone Co, Ducor Telephone Company, Pinnacles Telephone Co and The Siskiyou Telephone Company.
- · Closes the proceeding.

SAFETY CONSIDERATIONS:

• Cost of Capital rates in this decision will support the Commission's goal to assure that residents in rural communities within California will have access to reliable and affordable telephone and broadband service.

ESTIMATED COST:

• The cost of capital will impact the amount that each small Local Exchange Carrier draws from the California High-Cost Fund - A.

Actual cost of debt set for Calaveras (2.84%), Foresthill (2.74%), Kerman (3.00%), Ponderosa (2.9%), Sierra (3.83%) and Volcano (5.22%) and a cost of debt based on average of the lowest and highest of the above six companies (3.98%) applied to four companies with no debt at the time of the application Cal-Ore, Ducor, Pinnacles and Siskiyou.

• Cost of Capital rates in this decision will support the Commission's goal to assure that residents in rural communities within California will have access to reliable and affordable telephone and broadband service.

ESTIMATED COST:

• The cost of capital will impact the amount that each small LEC draws from the California High-Cost Fund -A (CHCF-A).

PROPOSED OUTCOME:

• Provide the installed networks free broadband service to 245 units in low-income housing. These projects will deploy broadband network infrastructure to publicly supported housing developments capable of 25 Mbps download and 3 Mbps upload speeds.

SAFETY CONSIDERATIONS:

 The Deployment of affordable broadband in public housing will improve access to government and ehealth services, which improves safety.

ESTIMATED COST:

• \$279,415.44.


ESTIMATED COST:
